Foreword

Welcome to the latest edition of Firm Foundations – the early years and childcare newsletter for Medway.

The coming period is likely to be a challenging one. The government and the local authority face some difficult decisions over funding, and we await with interest how this might impact on early childhood services locally. Whatever the outcome, I think we will need to get used to hearing more about getting absolute best value for money, working together smartly, and targeting our resources precisely to effect the greatest outcomes for children and families.

This term also sees the introduction of the new early years single funding formula, and preparations for the extended flexible free offer (of 15 hours per week) from September. Change is never easy, but I would like to put on record my admiration for the way in which settings in Medway have responded so positively. During the next couple of months we shall continue to work with you, through meetings such as the foundation stage leaders' briefings, in advance of the new regulations coming in to force in the autumn.

Finally I'd like to offer my congratulations to those practitioners, settings and organisations whose achievements are described in this newsletter.

- Collectively, the first stage of the target to establish integrated early childhood services in Medway has been achieved with the completion of the programme to provide a Sure Start Children's Centre in every community. If you haven't visited your local Children's Centre, now is the time to do so.
- Another group of Medway settings have attained the accolade of being judged "Outstanding" by Ofsted in their recent inspections testimony to many years of hard graft and a relentless pursuit of quality.
- And the remarkable expansion of Medway's graduate early years workforce continues with the award
 of Foundation Degree in Early Years Studies to a further cohort of extremely clever and committed
 students.

Scrap Store

The Early Years and Childcare Professional Development Centre will continue to open the Scrap Store for another six months. Whilst it has been popular the centre has some concerns regarding its sustainability. The PDC currently have some suppliers who they collect from on a regular basis but would still like to make more contacts; If you are aware of any companies who have suitable materials, please contact the PDC with their details.

For PVI's and Schools, membership renewal will be £5.00 and will last until the 31st September 2010. As before, filling your bag will cost £1.50 each time you visit. If you forget your bag, it can be replaced for £2.00. There are limits on the amount of resources that can be taken at one time; these limits are clearly labelled on each item.

There will be no specific opening times in the next six months; to arrange a visit to the Scrap Store practitioners are asked to contact the centre to arrange a time for their visit. Please note providers will continue to be limited to visiting once a fortnight as before.

Drop-in Sessions - Tuesday 15th June and Friday 9th July 10.00am - 4.00pm

These sessions are designed to support practitioners working in the Early Years Foundation Stage by providing an opportunity to meet with colleagues and members of the Quality Team. There will be materials and equipment to help you provide appropriate resources and experiences for use with the children in your settings. Full details of the sessions are in the Summer Term training programme.

Nursery Education Funding - Changes to payments

By the time you're reading this edition of Firm Foundations, you should have had your first monthly Nursery Education Fund (NEF) payment under the new formula. As you are aware this is now paid in monthly instalments rather than in two termly amounts.

We believe that this regular income will make it easier for settings to manage their finances over the year. However, we suggest that all settings examine the way they pay expenses such as rent etc to ensure, wherever possible, that payments going out from your accounts reflect the new arrangement of monthly income.

Children's Centre Validations

This year looks set to be an exciting one for Sure Start Children's Centres across Medway, and for many of them the beginning of 2010 called for lots of celebration.

All 10 second phase Sure Start Children's Centres in Medway became officially validated centres, after receiving confirmation from the Department of Children, Schools and Families (DCSF), that they offer the full core offer of services, support and activities for children and families.

The confirmation comes as Medway prepares for the final instalment of children's centres to be completed later this year, with new centres developing in Rochester and Rainham, fulfilling the pledge to provide a centre in every community.



In order to receive this recognition as providers of core services to young children and families, the centres must provide a specific range of services and activities.

These include:

- Drop in activity sessions for children such as stay and play
- Child and family health services
- Active involvement with parents
- · Family support services
- Support for children and parents with special needs
- Support for childminders and carers

Mark Holmes, strategic manager for early years services at Medway Council said, "I would like to congratulate all of the Sure Start Children's Centres in Medway that have been officially validated. This is the result of the care, hard work and enthusiasm of all of the staff and partners working at each one of our Sure Start Centres to make them enjoyable and friendly places, where young children can learn, play and grow.



Our collective aim is to meet the needs of local families and children by offering support and guidance, and high quality experiences, so that children get the best start in life. I would urge everyone to encourage families we know and work with to go along to their local centre and see the wide variety of outstanding services and information available to them.

With the last of the construction work nearing completion, and all of our newest centres having been officially approved by the DCSF, we are now on the verge of fulfilling our pledge to provide a children's centre in every community throughout Medway, so that every family can benefit from all that they have to offer."

By the summer of this year, there will be 19 Sure Start Children's Centres across Medway, with new centres based at:

Parent craft - 'Bump Club'

Last term Saxon Way Children's Centre and Medway Primary Care Trust worked in partnership to provide a parent craft class, 'Bump Club'.

The workshop was delivered to expectant parents who were invited to the class by their midwives and provided parents with information on what to expect around the birth of a child, offering practical advice and demonstrations on how to wash their baby and various other essential parenting techniques. The class was designed to encourage the expectant parents and equip them with the skills they will need to look after their new arrival and the confidence to do so.





This was followed by a 'dads only' group which focused on relationships and what to expect when their newborn arrives; the session offered information on how to offer support to their partners with the new arrival including practical advice and support. Dads-to-be put on their very own baby bumps to gain a greater understanding of pregnancy from their partner's perspective.

We are required to reconcile every child on headcount forms from all providers BEFORE we can make ANY payments. Any headcount forms returned late delay this process and may delay payments.

Meeting the EYFS Welfare Requirements - Paediatric First Aid

We would like to remind settings and schools that it is a requirement that "At least one person who has a current paediatric first aid certificate must be on the premises at all times when children are present. There must be at least one person on outings who has a current paediatric first aid certificate." EYFS Statutory Framework (2008:26)

Through discussions with practitioners it has come to our attention that the nominated first aider does not necessarily have the paediatric first aid certificate and we would therefore strongly advise that settings and schools check that they meet this statutory requirement. Medway Council also requires settings to keep a record of any first aid training undertaken and a record of appropriately trained adults in the setting.

Medway Council does not endorse or recommend any particular organisation or company, however we are able to identify that the following companies meet the welfare requirements for the EYFS.

Data Protection

It is likely that your work as a childcare / early years provider means that you keep details about other people on a computer. If you haven't already done so, you may need to notify the Information Commissioner's Office (ICO) that you are a "data controller" for data protection purposes.



The ICO suggests that providers' data protection responsibilities under the Data Protection Act are as follows:

- If you keep all your childcare records on paper, you do not need to notify the Information Commissioner under the Data Protection Act.
- If you keep information about the names, ages and addresses of children and their parents, details of any payments, or any data for staff administration on a computer, purely for accounts and records purposes, you are also exempt from notification.
- But, if you keep more extensive records, or information of a more sensitive nature, for example about children's health, behaviour or development on a computer, then you need to contact the ICO to find out if you are required to notify them.

We strongly recommend that if you are in any doubt as to your responsibilities you should contact the ICO as soon as possible for their advice.

You can check whether you need to notify the ICO, and also complete your notification online at www.ico.gov.uk. Alternatively you can request the forms by calling the Notification Helpline on 01625 545740 or 08456 306060. There is a cost of £35 per year to be registered.

Places to visit in Medway

The 'Stay and Play' session is a fantastic way to help parents feel more involved in their children's early learning; allowing them to get to know more about the setting and gain a greater understanding of how their children are progressing.

I found it really hard to leave him at such a young age, I always felt guilty, until one day I was invited to a 'Stay and Play' session at the nursery. It was then that I saw for myself how much fun he had with the carers and his friends, and all the excellent grounding he was having before he started school, both on a social and academic level. Starfish Malawi

For the last two years Kloisters Kindergarten have collected a range of resources on behalf of the charity Starfish Malawi, an organisation that seeks to make a difference in education, vocational training and AIDS awareness in Africa.

This year Kloisters managed to collect over 3 car loads of equipment, including toys, books, paper, paint, pencils, tables and chairs and a substantial quantity of large equipment, for example climbing equipment, sensory items and outdoor play items, to be packaged up and transported to Malawi by container.

Kloisters have established an excellent relationship with the charity and the nursery school in Malawi, receiving a letter of thanks from the charity and maintaining regular monthly contact with the setting via newsletters and lesson plans. Supporting the children in Hope Nurseries in Malawi has an amazing impact on their lives; the children are always thrilled with their new toys and the support offered through Starfish has made teaching and learning very exciting for the teachers and children alike.

As a gift of thanks the children in Malawi sent the staff and children at Kloisters a selection of hand carved jungle and water animals that were carved by the children themselves. To show them off, the pre-school classes at Kloisters have made backdrop scenery for the wooden animals and they are now proudly on display for all to see!

National 'Stop the Rot' day

This year's national Stop the Rot day saw over 100 nurseries across the UK 'Smile like a Crocodile' and take part in 'The Big Brush'; the event took place on Thursday 18th March at 9.30am and saw around 2,000 children brushing their teeth simultaneously for two minutes.

The children at Saxon Way Children's Centre, Gillingham, joined in the fun of 'The Big Brush' armed with their new toothbrushes and ably assisted by Smiley the Crocodile. Throughout the morning children learnt about the importance of good dental habits and how to fulfil the campaign's 'smile promises'. Those who took part were rewarded with stickers and a certificate along with lots of other goodies provided by the Oral Health Promotion Team and the National Day Nursery Association.

Everyone who took part felt a great sense of achievement and a fantastic time was had by all!



Chinese New Year Celebrations

The staff and children at Hempstead Pavilion Playgroup celebrated the Chinese New Year in style this February with a whole range of activities. Children danced in the year of the tiger, dressing in Chinese costumes and dancing with the playgroup's own Chinese dragon.

Outstanding Ofsted results

Congratulations to four more settings who have joined the list of Medway's 'Outstanding' early years providers.



Last November Busy Builders in Gillingham had cause to celebrate after achieving an 'Outstanding' Ofsted rating. Open since 1990, Busy Builders is a sessional pre-school predominantly serving the local community providing support to children from a variety of backgrounds with a range of needs. Ofsted declared the overall quality of the provision to be outstanding, praising staff's knowledge of the children's individual needs, the partnerships they have made with other professionals to further assist children with additional learning needs and the support given to children and parents with English as an additional language as just some of the key areas of good practice.

"Adults provide a warm, caring and consistent approach to children's differing needs."

Allhallows Pre-School, which first opened its doors in 1997, was also judged as 'Outstanding' in its latest Ofsted inspection in December. The inspector remarked that the children experience a caring, stimulating environment where they have good access to a range of resources, helping them to develop in all six areas of learning; areas for improvement are quickly identified and adapted by the setting, helping to provide a more exciting environment for the children to use. The setting was also praised for its links with the local school and the partnerships staff have formed with parents.

Parkwood Pre-School are another Medway setting to be deemed as 'Outstanding' following their latest inspection in January. Based in the grounds of Parkwood School, Parkwood Pre-School has provided sessional care for children aged 3 and 4 since its opening in 1997. The setting is inclusive, providing support to children who speak English as an additional language and children with special education needs. Ofsted declared the quality of the provision to be outstanding in all areas, particularly praising the setting's resources that are used to help children learn more about the world around them and the manager's strong vision for the setting.

This February The Orchard Pre-School in Rainham was also judged to be 'Outstanding'. The setting originally opened in April 2000 and offers a variety of sessions to children aged 3 and 4 years of age. All children at the setting are given the opportunity to learn British Sign Language, with visual aids such as posters showing pictures and signing actions being displayed around play areas. Inspectors praised the staff's knowledge of each child's specific needs and interests with activities being planned around children's interests and requests ensuring children are eager to participate in all activities available to them.

Congratulations to Medway Early Years Graduates



Medway Early Years Service would like to extend many congratulations to the September 2007 cohort of Foundation Degree Early Years Studies who graduated on Saturday 13th March 2010.

These practitioners have managed to successfully balance the demands of family and work alongside the foundation degree. Undertaking to complete further qualifications is a brave step but one that these graduates undertook.

Many of these practitioners have decided to complete this particular pathway by continuing on to gain a BA (Hons) Early Years Studies (with a recommendation for Early Years Professional Status). This has also led to a pay enhancement of up to £5,000 for their role as the EYP leading on the delivery of the EYFS.

Medway Council has a vision for quality experiences to be delivered by highly qualified practitioners across the EYFS. These practitioners are part of a growing graduate body within the Private, Voluntary and Independent sector that is contributing towards high quality experiences for our youngest children.

Establishing a graduate workforce within our PVI sector has been made possible through generous funding from the Department of Children, Schools and Families, in the form of the Graduate Leader Fund. Medway Early Years Service is currently funding the seventh cohort at Canterbury Christ Church University and we are looking to support an eighth in September 2010.


