Renewal of funding

Disability Access Funding (DAF)

Please remember to check with your parents to see if they are in receipt of Disability Living Allowance (DLA). If they are then on elearning you will find the forms to allow you to claim the DAF additional funding to support children. If you apply before April 2019 you will receive £615 for the child and then if you apply after April 2019 you will receive a further £615 to provide additional support. Remember this funding is only for children in Nursery and is ring fenced for Early Years.
